TERMS AND CONDITIONS

 Unlimited Access to Classes. Member shall, upon payment of the Membership Dues, have unlimited access to yoga/fitness classes offered by Body Shop at its studio located at 1917 Dutton Drive, suite 110, San Marcos, Texas, 78666 (the "Studio").

- 2. <u>Dues</u>. Upon execution of this Membership Agreement, Member shall pay to Body Shop the Membership Dues pursuant to Member's chosen payment plan.
